Closure of Share Purchase Plan

Dampier Gold Limited (ASX: DAU) (“Dampier Gold” or “the Company”) is pleased to announce that the Company has raised \$167,000 at 14.5c per Share, from the recent Share Purchase Plan (“SPP”) which closed on Thursday, 8 November 2012.

The SPP was conducted following a placement to strategic investor Columbus Minerals which raised \$1.06 million, also at 14.5c per Share.

The Directors retain the discretion to place SPP shortfall Shares at the same price, subject to Shareholder approval at the forthcoming Annual General Meeting. The SPP participation plus shortfall commitments are expected to raise close to \$0.5 million. The total amount raised by placements and the SPP process is expected to be close to \$1.5 million.

Funds raised will be used to advance exploration at the Company’s flagship Plutonic Dome Project.

Dampier Gold would like to thank all of its Shareholders who have participated in the SPP for their ongoing support.
